**CONTRACT OF AGREEMENT**

This agreement made this 05<sup>th</sup> day of November, 2021 between the *Local Government Unit of Anao, Tarlac* (hereinafter called "the Entity") on one part and **WALTERMART SUPERMARKET INC.** (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity requested for Quotations for its **Supplementary Feeding Program in Day Care (11<sup>th</sup> Cycle)** and has accepted the financial proposal for the delivery of various grocery items in the sum of **Six Hundred Eighty Eight Thousand Nine Hundred Forty Pesos and 40/100 (Php 688,940.40)** (herein called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH as follows:

1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
  - (a) The Financial Proposal /Quotation;
  - (b) The Schedule of Requirements;
  - (c) The Technical Specifications;
  - (d) The General Conditions of the Contract;
  - (e) The Special Conditions of Contract;
  - (f) and the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier, in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in manner prescribed by the contract.
