CONCRETING OF LABABIT ROAD WITH A LENGTH OF MORE OR LESS ONE (1) KILOMETER AND 12" THICKNESS
Barangay Rizal, Anao, Tarlac

4. The *Barangay Rizal, Anao, Tarlac*, intends to apply the sum of *One Million Pesos (P1,000, 000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Concreting of Lababit Road with a length of more or less one (1) kilometer and 12" thickness at Barangay Rizal, Anao, Tarlac*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
5. The *Barangay Rizal, Anao, Tarlac*, now invites bids for the *Concreting of Lababit Road with a length of more or less one (1) kilometer and 12" thickness at Barangay Rizal, Anao, Tarlac*. The project duration is sixty (60) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
6. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. Interested bidders may obtain further information from *the Barangay Rizal, Anao, Tarlac* and inspect the Bidding Documents at the address given below from *8:00am to 5:00 pm*.
8. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *One Thousand Pesos (P1,000.00)*.
9. Bids must be delivered to the address below on *July 31, 2019 at 10:00 AM at the Barangay Hall of Rizal, Anao, Tarlac*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted
7. The *Barangay Rizal, Anao, Tarlac*, reserves the right to accept or reject any bid, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
