INVITATION TO BID FOR

IMPROVEMENT OF MULTI-PURPOSE HALL – BRGY. BAGUINDOC, ANAO, TARLAC

1. The *Barangay Government of Baguindoc, Anao, Tarlac*, intends to apply the sum of *Fifty Nine Thousand Pesos (59,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Improvement of Multi-Purpose Hall – Brgy. Baguindoc, Anao, Tarlac*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Barangay Government of Baguindoc, Anao, Tarlac* now invites bids for the *Improvement of Multi-Purpose Hall*. Bidders should have completed, within *ten (10) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the *Barangay Baguindoc, Anao, Tarlac* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be purchased by Interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Hundred Pesos (P 500.00)*.
6. Bids must be duly received by the BAC Secretariat at the address below on or before *November 6, 2019, 9:00 A.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *November 6, 2019, 9:00 A.M.* at the *Barangay Hall of Baguindoc*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The *Barangay Government of Baguindoc, Anao, Tarlac*, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
