INVITATION TO BID FOR
Improvement of Public Market Phase 3
@ Barangay Poblacion, Anao, Tarlac

1. The Local Government Unit of Anao, through its authorized appropriation under the CY 2019 20% Development Fund intends to apply the sum of **One Million Three Hundred Ninety Six Thousand Three Hundred Ninety Three Pesos and 15/100 (P1,396,393.15)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, **Improvement of Public Market Phase 3 @ Barangay Poblacion, Anao, Tarlac**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Anao now invites bids for the Project, **Improvement of Public Market @ Barangay Poblacion, Anao, Tarlac**. Completion of the Works is required One Hundred Twenty (120) days from the commencement of work. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the Municipality of Anao and inspect the Bidding Documents at the address given below during office from 9:00am to 4:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 9- 16, 2020** from the address below and upon payment of a non-refundable fee in the amount of Five Thousand Pesos (P5,000.00).
6. Bids must be duly received by the BAC Secretariat at the address below on or before **January 17, 2020 at 10:00am**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **January 17, 2020 at 10:00am** at Mayor's Conference Room, Anao, Tarlac. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
7. The Local Government Unit of Anao reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
