MUNICIPAL ORDINANCE NO. 2005-108

AN ORDINANCE DECLARING THE PERMANENT CLOSURE OF CALLE JON ROAD LOCATED AT BARANGAY POBLACION, ANAO, TARLAC.

BE IT ORDAINED by the Sangguniang Bayan of Anao, Province of Tarlac that:

Section 1. The Calle Jon Road with an actual width of 9.8 meters and actual length of 57.2 meters as measured from the existing fence to fence at center of both Lot No. 831-B-3 and Lot No. 832-D, or with a total area of 560.56 square meters, more or less, is hereby declared permanently closed to public access.

Section 2. The permanent closure of Calle Jon Road serves to isolate the privacy of the existing Pagulidanan Building and the Day Care Center Building which were constructed as permanent in nature and likewise, to safeguard the government properties and facilities therein.

Section 3. This Ordinance shall take effect upon its approval.
