AN ORDINANCE NAMING THE NEWLY CONSTRUCTED MUNICIPAL PLAZA AS "LIWASANG PROCOPIO" IN HONOR AND MEMORY OF ANAO'S HEROIC BUT LARGELY FORGOTTEN SON, DON PROCOPIO EVANGELISTA.

BE IT ORDAINED by the Sangguniang Bayan of Anao, Province of Tarlac that:

SECTION 1. Naming of the Municipal Plaza as "LIWASANG PROCOPIO"

The newly constructed municipal plaza of Anao is hereby named as "LIWASANG PROCOPIO".

SECTION 2. The "Liwasang Procopio" shall be utilized and made accessible to the public.

SECTION 3. REPEALING CLAUSE

All previous ordinances or parts thereof, in conflict with or inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect upon approval.
