










MUNICIPAL ORDINANCE NO. 2017-172

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2003-095 – AN ORDINANCE REQUIRING ALL TRICYCLE OPERATORS IN THE MUNICIPALITY AND FROM OTHER NEARBY MUNICIPALITIES WHO OPERATES AND TRANSPORTS PASSENGERS INSIDE THE MUNICIPALITY TO REGISTER THEIR TRICYCLES AND SECURE THEIR MOTORIZED TRICYCLE OPERATORS PERMIT (MTO) IN ANAO.

BE IT ENACTED by the Sangguniang Bayan of Anao, Province of Tarlac that:

Section 1. DEFINITION OF TERMS

- 1.1. Operator – the owner of the tricycle for hire or for private use.
- 1.2. Other Operators – the owners of tricycles for hire outside the municipality but operating inside the territorial jurisdiction of the town.
- 1.3. MTO – Motorized Tricycle Operators Permit is a document granting franchise or license to a person, natural or juridical, allowing him to operate tricycle-for-hire over specified zones.
- 1.4. Tricycle – three (3) wheeled vehicle, private or for hire in capacity.
- 1.5. Tri-wheeler – three (3) wheeled vehicle, the modern type tricycle.

Section 2. GENERAL PROVISIONS – This Ordinance shall be imposed to the following:

- 2.1. All existing and new tricycle/tri-wheeler operators within the territorial jurisdiction of the municipality.
- 2.2. All operators of tricycles and tri-wheeler for hire, transporting passengers inside the territorial jurisdiction of the municipality, entering side streets, barangay and municipal roads of the town.
- 2.3. All operators of tricycle and tri-wheeler for hire, plying the route of Anao-Paniqui, Anao-San Julian, Baguindoc-Moncada, Casili-Moncada, Sinense-Moncada, Suaverdez-Moncada, and Bantog-San Manuel

Section 3. IMPOSITION OF FEES:

- 3.1. There shall be collected an annual registration fee for every motorized tricycle/tri-wheeler operating in the Municipality in the amount indicated hereunder:

Motorized tricycle/tri-wheeler for private use	-	P50.00/annum
Motorized tricycle/tri-wheeler for hire	-	P110.00/annum

- 3.2. There shall be collected an annual franchise fee in the amount of P66.00 and franchise application fee of P33.00 per unit, for the operation of tricycle/tri-wheeler for hire.

Section 4. EXEMPTION

- 4.1. All tricycle/tri-wheeler operators traversing the national or provincial road adjoining the Municipalities of Nampicuan, Nueva Ecija and Moncada, Tarlac shall be exempted from securing their MTOs in the municipality.



4.2. All operators for tricycles/tri-wheelers for private use only shall be required for Registration and not necessarily be required to secure their MTOPs.

Section 5. PENALTY CLAUSE

A violator of this Ordinance shall be fined an amount of Five Hundred Pesos (P500.00) or required to render a community service for two (2) days or both upon the discretion of the Court.

Section 6. COMPROMISED SETTLEMENT FEE

The Municipal Mayor is hereby authorized to enter into an Extra-Judicial or Out-of-Court settlement for any offense committed by a violator under this Ordinance. Provided, however, that the offender shall pay an amount of Six Hundred Pesos (P600.00) as a compromised settlement fee to the Municipal Treasury Office such that he will no longer be required to render community service.

Section 7. REPEALING CLAUSE – All previous or ordinances, inconsistent with the provisions of the Ordinance are hereby repealed.

Section 8. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon approval.
