





**RESOLUTION NO. 2020-174**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE RAFAEL M. NARAL TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR THE PROVISION OF FINANCIAL ASSISTANCE TO LOW INCOME FAMILIES AFFECTED BY COVID-19 PANDEMIC THROUGH EMERGENCY SUBSIDY PROGRAM (ESP).**

**WHEREAS**, Department of Social Welfare and Development (DSWD) Field Office III, Regional Director Marites M. Maristela, CESO III, informed the Municipal Mayor, Honorable Rafael M. Naral, that their Office, Field Office III is ready to collaborate with the Local Government of Anao to effect the expedient and efficient delivery of DSWD Response and Recovery Interventions as mandated under Republic Act 11494 otherwise known as "Bayanihan to Recover as One Act" to implement Social Protection Program;

**WHEREAS**, the Municipal Mayor, thru letter dated November 28, 2020, signified and informed the DSWD Regional Director, Field Office III, the LGU's interest to facilitate the distribution of relevant social protection programs of DSWD;

**WHEREAS**, it is stated in the letter of the Regional Director that a Sangguniang Bayan Resolution authorizing the Municipal Mayor to enter into a Memorandum of Agreement with DSWD pertaining to said program is a pre-requisite for an LGU to be considered;

**NOW, THEREFORE**, on motion presented and duly considered by the Body:

**RESOLVED, AS IT IS HEREBY RESOLVED**, to adopt this **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE RAFAEL M.
