RESOLUTION AUTHORIZING THE HONORABLE RAFAEL M. NARAL, MUNICIPAL MAYOR OF THE MUNICIPALITY OF ANAO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTRAL LUZON FOR HEALTH AND DEVELOPMENT REGARDING THE GRANT OF ACTIVE HAZARD DUTY PAY (AHDP) AND SPECIAL RISK ALLOWANCE (SRA) TO QUALIFIED FRONT LINERS DIRECTLY CATERING TO COVID-19 PATIENTS.

WHEREAS, Department of Health Central Luzon Center for Health and Development, as the implementing arm of the Department of Health within Central Luzon is recognizing the invaluable contribution of all public and private health workers at this time of national health emergency, and thus, President Rodrigo Roa Duterte signed the grant of Active Hazard Duty Pay (AHDP) and Special Risk Allowance (SRA) to all qualified front liners directly catering to COVID-19 patients for every month of service rendered;

WHEREAS, the LGU shall be directly responsible and accountable for the grant and disbursement of AHDP and SRA to qualified public health workers subject to the conditions provided for in the guidelines under joint DBM and DOH Circular Number 1 and 2 dated November 25, 2020 or the "Guidelines on the grant of the COVID-19 Active Hazard Duty Pay" and Guidelines on the Grant of the COVID-19 Special Risk Allowance to Public and Private Health Workers, respectively;

WHEREAS, both parties should enter into a Memorandum of Agreement pursuant to Department Order No. 2020-0725 dated November 25, 2020 and Sub-Allotment Advice No. 20-11-0390 dated November 26, 2020 on the release of funds to the LGU, its utilization, liquidation and reporting;

WHEREAS, Section 455 of Republic Act 7160 or otherwise known as Local Government Code of 1991, provides that Local Chief Executives (LCEs) shall represent the Municipality in all business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance;

NOW, THEREFORE, on motion of Coun. Rodolfo F. Guerrero and duly seconded by Coun. Cesar C. Bautista:

RESOLVED AS IT IS HEREBY RESOLVED, to Authorize the Honorable Rafael M. Naral, Municipal Mayor of the Municipality of Anao to enter into a Memorandum of Agreement with the Department of Health Central Luzon for Health and Development regarding the grant of Active Hazard Duty Pay (AHDP) and Special Risk Allowance (SRA) to Qualified Front Liners Directly Catering to COVID-19 Patients.

RESOLVED FURTHER, that copy of this Resolution be furnished the Department of Health Central Luzon for Health and Development for their information.

RESOLVED FINALLY, that copy of this resolution be forwarded to Hon. Rafael M. Naral for his information and appropriate action.
