





RESOLUTION NO. 2021-019

RESOLUTION AUTHORIZING THE HONORABLE RAFAEL M. NARAL, MUNICIPAL MAYOR OF THE MUNICIPALITY OF ANAO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE III REGARDING THE SOLAR POWERED FERTIGATION SYSTEM-8 (SPFS-8).

WHEREAS, Chapter 3, article 1, section 444-(b)1(VI) of the Local Government Code of 1991 states that "upon authorization by the Sangguniang Bayan, the Municipal Mayor may represent the Municipality in all its transactions and all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made pursuant to law or ordinance;

WHEREAS, Department of Agriculture in pursuit of its mandate and under the Republic Act 8435 (Agriculture and Fisheries Modernization Act (AFMA) of 1997) undertakes the implementation of agricultural policies and programs that embraces food security, poverty alleviation and social equity in the agricultural sector of this country;

WHEREAS, the Local Government Unit of Anao is a partner of the Department of Agriculture in the implementation of the Small-Scale Irrigation Projects (SSIPs);

WHEREAS, per site validation and evaluation conducted in the Province of Tarlac, Barangay Suaverdez Farmers Association of Anao, Tarlac met the eligibility requirements and is qualified to be beneficiary of the SPFS-8 project.

NOW, THEREFORE, on motion of Coun. Cesar C. Bautista and duly seconded by the Body:



RESOLVED FURTHER, that copy of this Resolution be furnished the Department of Agriculture - Regional Field Office III for their information.


RESOLVED FINALLY, that copy of this resolution be forwarded to Hon. Rafael M. Naral for his information and appropriate action.

ADOPTED UNANIMOUSLY by the Members of the Sangguniang Bayan present during their regular session held at the SB Session Hall on January 11, 2021.


