



RESOLUTION NO. 2021-02

RESOLUTION ADOPTING PRESIDENTIAL PROCLAMATION NO. 760, S. 2014 DECLARING THE MONTH OF JANUARY AS "ZERO WASTE MONTH".

WHEREAS, Republic Act No. 9003 or the "Ecological Solid Waste Management Act of 2000", promotes environmental awareness and action among the citizenry and institutionalizes public participation in the development of national and local, integrated, comprehensive and ecological waste management program;

NOW, THEREFORE, on motion presented by Coun. Rodolfo F. Guerrero and seconded by the Body:


