RESOLUTION NO. 2021-024

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE RAFAEL M. NARAL, ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LANDBANK OF THE PHILIPPINES ENGAGING THE LOCAL GOVERNMENT UNIT AS AGENT BANKING PARTNER (ABP) FOR DATA GATHERING THRU PEN AND PAPER AND ELECTRONIC METHODS TO ASSIST IN THE KNOW YOUR CLIENT (KYC) PROCESS FOR THE OPENING OF LAND BANK MASTERCARD PREPAID CARD FOR UNBANKED CONSTITUENTS DURING THE PHYLSYS ID REGISTRATION.

WHEREAS, Book 3, title 2, Chapter 3, article 1, section 444-(b)1(VI) of the Local Government Code of 1991 states that "upon authorization by the Sangguniang Bayan, the Municipal Mayor may represent the Municipality in all its transactions and all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made pursuant to law or ordinance".

WHEREAS, the Landbank of the Philippines is a government financial institution duly organized and existing under and by virtue of R.A. 3844, as amended, with principal office at 1598 M.H. Del Pilar corner Dr. J. Quintos Streets, Malate, Manila;

WHEREAS, this aims to support the National Government's financial Inclusion Agenda by providing transactional accounts to the unbanked to make future government disbursements more efficient;

WHEREAS, the LGU-Anao will assign an area and personnel who will perform and execute the detailed duties;

NOW, THEREFORE, on motion presented and duly considered by the Body;

RESOLVED, AS IT IS HEREBY RESOLVED to adopt this RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE RAFAEL M.
