RESOLUTION NO. 2021-036

RESOLUTION TO REQUESTING HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR FUNDING THE CONCRETING OF PUGO ROAD IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00).

WHEREAS, on January 8, 2021, the Department of Budget and Management (DBM) issued Local Budget Circular No. 131 granting financial assistance to qualified Local Government Units (LGUs) in need of funds for their development programs in their jurisdiction;

WHEREAS, the Municipality of Anao, the smallest town in the Province of Tarlac, fifth class in category and eighty percent (80%) dependent in the Internal Revenue Allotment (IRA), with limited resources in the municipal coffers cannot shoulder the financing especially in the concreting of our farm to market roads;

WHEREAS, the Concreting of Pugo Road will ease the problem of the residents of the said area who were having hard time passing through the said road during the rainy season when the road becomes too muddy and making it hard for them to traverse;

WHEREAS, the above-mentioned priority projects are part of the duly-approved Local Development Investment Program and Annual Investment Program of the LGU;

WHEREAS, the municipality lacks the financial capability to implement the aforementioned project, thus, earnestly requests to Secretary Wendel E. Avisado of the DBM for funding the Concreting of Pugo Road Project in the Municipality in the amount of Ten Million Pesos (Php10,000,000.00)

NOW, THEREFORE, on motion presented and duly considered by the Body, be it;

RESOLVED, that this Body hereby request **RESOLUTION TO REQUESTING HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR FUNDING THE CONCRETING OF PUGO ROAD IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00).**


