RESOLUTION REMINDING THE LOCAL CHIEF EXECUTIVE, HONORABLE RAFAEL M. NARAL, SUBMISSION OF REPORT TO THE SANGGUNIANG BAYAN ON OR BEFORE MARCH 31 OF EACH YEAR ON THE SOCIO-ECONOMIC, POLITICAL AND PEACE AND ORDER CONDITIONS AND OTHER MATTERS AFFECTING THE MUNICIPALITY AS PER SECTION 97 OF THE LOCAL GOVERNMENT CODE AND DILG MC NO. 07-24, S. 2007.

WHEREAS, DILG MC No. 2007-24 amends Department Circular No. 92-17, s. 1992, particularly the section on Form and content thereof, such that the Annual Report shall embody:

- The immediately preceding year's performance (over-all administrative capability), productivity (service delivery), and development conditions (state of development) thereby providing a comprehensive information on the actual state of local governance in in a province, city or municipality;
- The issues, challenges or gaps that have to be addressed during the ensuing year.

WHEREAS, per Section 97 of the Local Government Code, Annual Report – on or before March 31 of each year, every Local Chief Executive shall submit an annual report to the Sanggunian concerned on the **SOCIO-ECONOMIC, POLITICAL AND PEACE AND ORDER CONDITIONS** and other matters concerning the local government unit which shall cover the immediately preceding calendar year;


RESOLVED FURTHER, that copy of this resolution be furnished to the Honorable Rafael M. Naral, Municipal Mayor, for his information and appropriate action.


