MUNICIPAL ORDINANCE NO. 2014 - 157

AN ORDINANCE CREATING THE OFFICE FOR THE SENIOR CITIZENS AFFAIRS (OSCA), IN THE MUNICIPALITY OF ANAO AS MANDATED BY RA 9994.

Be it ordained by the Sangguniang Bayan

- that-

Section 1. Title; This Ordinance shall be known as the "ORDINANCE CREATING THE OFFICE FOR THE SENIOR CITIZEN AFFAIRS (OSCA) in the Municipality of Anao.

Section 2. Legal Basis – This Ordinance is based on the provision of Section 12 and 23 of RA 9257 "An act granting additional benefit and privileges to Senior Citizen, amending for the purpose RA No. 7432; Otherwise known as an act to maximize the contribution of Senior Citizen to nation building, grant benefits and special benefits, and special privileges and for other purposes.

Section 3. Purpose – As one of the basic services and facilities to be undertaken by the municipality the establish mechanisms whereby the contribution of the Senior Citizens are maximize; adopt measures whereby the Senior Citizens are assisted and appreciated by the community; as a whole establish a program beneficial to the Senior Citizen, their families and the rest of the community that they serve; and established community based health and rehabilitation programs in every political unit of society.

Section 4. Definition of Terms – The terms for the purpose of this Ordinance shall mean:

- a. Senior Citizen or "Elderly" shall mean any resident citizen of the Philippines at least sixty (60) years old.
- b. OSCA – shall refer to the office for the Senior Citizen Affairs headed by a Senior Citizen.

Section 5. An authority and Functions of the (OSCA)

5.1 Authority – This Ordinance is enacted to supplement provision of the existing laws and Ordinances in the Municipality related to the granting and privileges to Senior Citizens.

5.2. Functions – The following are the functions of the Office for Senior Citizens Affairs.

5.2.1. In consultation with the City or Municipal Social Work and Development Officer and duly registered senior citizen organizations, to plan, develop, implement, consolidate, and monitor yearly work programs in pursuance of the objectives of the Act and its Rules;

5.2.2. To draw up a least of available and required services which can be provided by the registered federations and associations of Senior Citizens;





5.2.3. To maintain and regularly update on a quarterly basis the list of senior citizens and to issue national uniform individual identification cards and purchase booklets, free of charge, which shall be valid anywhere in the country;

5.2.4. To serve as a general information and liaison center the needs of the senior citizens;

5.2.5 To monitor compliance of the provisions of the Act and its Rules particularly the grant of special discounts and privileges to senior citizens;

5.2.6. To report to the Mayor, any person, natural or judicial, establishments, business, entity, institution or agency found violating any provision of the Act and its Rules;

5.2.7. To facilitate the creation of a city or municipality coordinating and monitoring board consisting of OSCA Head, the City or Municipal Social Work and Development Officer and the presidents of concerned duly registered senior citizens organizations to deliberate and act on the complaints;

5.2.8. To assist senior citizens in filling complaints or charges against any person, natural or judicial, establishment, institution, or agency refusing to comply with the privileges under the Act before the Department of Justice (DOJ), the Provincial Prosecutor's Office, the regional or the municipal trial court, the municipal trial court in cities, or the municipal circuit trial court;

5.2.9. To assist and coordinate with the concerned person, natural or judicial, establishment, institution or agency in investigating fraudulent practices and abuses of the discount and privileges exclusively granted to senior citizens; and

5.2.10. To establish linkages and work together with the accredited NGOs, people's organizations, and the barangays in their respective areas.

Section 6. Effectivity – This Ordinance shall take effect upon its approval




