**AN ORDINANCE DECLARING THE FOURTEENTH DAY OF MARCH OF EACH YEAR AS FARMERS' DAY.**

**BE IT ENACTED** by the Sangguniang Bayan of Anao in session assembled

**Section 1. Title**

This Ordinance shall be called **ANAO FARMERS' DAY ORDINANCE.**

**Section 2. Purpose**

The fourteenth day of March is hereby declared "Farmers' Day" to commemorate the importance of the Farmer-constituents to be observed with fitting activities to emphasize the significance of this day.

**Section 3. Plan of Activities**
