MUNICIPAL ORDINANCE NO. 2015-163

AN ORDINANCE ENSURING ROAD SAFETY AND PROTECTION TO THE COMMUTERS PARTICULARLY TO CHILDREN/MINORS BY PROHIBITING THE "SABIT" OR "TOP LOAD" BOARDING OF BUSES, JEEPNEYS, TRIMOBILES, AND OTHER MEANS OF TRANSPORTATION WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ANAO, PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES.

Be it enacted and ordained by the Sangguniang Bayan of Anao, that:

SECTION 1. TITLE. This Ordinance shall be known as the Road Safety Ordinance of the Municipality of Anao.

SECTION 2. PURPOSE. The purpose of this ordinance is to ensure the road safety and protection by informing the public, particularly motorists, that the observance of traffic laws and rules on road courtesy and discipline is a paramount duty taken on by them the moment they sit behind the wheels, especially when the purpose thereof is to serve the convenience of the public as operator/driver of public utility vehicles.

SECTION 3. MANDATORY ROAD SAFETY MEASURES – In the implementation of the purposes for which this Ordinance is enacted, the following are hereby declared as mandatory road safety measures:

3.a. Prevent any person, especially children/minors from boarding the vehicle as a "sabit" or "top load" passenger. For the purpose of this Ordinance, "sabit" or "top load" passenger refer to passenger who are aboard the roof of the vehicle or hanging on the outside front, back, or side portion thereof.

3.b. Ensure that children and minors aboard the vehicle are seated inside the vehicle and are far away from the door. Adult passengers shall give priority for children/minors to sit at the middle inside portion of the vehicle.

SECTION 4. PENALTIES – To ensure compliance with the provisions of this Ordinance, the following penalties shall be imposed to drivers or operators for violations thereof.

First Offense: Fine of 100.00 and confiscation of driver's license.
Second Offense: Fine of 300.00 and confiscation of driver's license.
Third and Succeeding Offense: Fine of 500.00 and confiscation of driver's license.

SECTION 5. DISPOSITION OF FINE. Fines collected shall accrue to the Municipal Fund.

SECTION 6. IMPLEMENTING MECHANISM – To achieve the intents and purposes of this Ordinance and to effectively carry out its provisions, the Philippine National Police and the Local Chief Executive shall act upon its enforcement.


SECTION 7. EFFECTIVITY – This ordinance shall take effect fifteen (15) days from posting at conspicuous areas, information drive campaign and all necessary reminders to inform passengers, drivers and operators of the provision thereof.


