



MUNICIPAL ORDINANCE NO. 2015-164

RECLASSIFYING TCT NO. 043-2014002758 REGISTERED UNDER THE NAME OF TARLAC I ELECTRIC COOPERATIVE, INC. (TARELCO I), CONTAINING AN AREA OF SIX HUNDRED FORTY FIVE SQUARE METERS (645 sq. m) MORE OR LESS, SITUATED AT BARANGAY SAN ROQUE, THIS MUNICIPALITY FROM RESIDENTIAL TO COMMERCIAL PURPOSES.

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Anao, Province of Tarlac;

-that-

Section 1. The Tarlac I Electric Cooperative, Inc. (TARELCO I), is intended for the construction, installation and commissioning of a 10 MVA Substation and 69 KV Line for the Municipality of Anao, which submitted the following requirements:

a. The Department of the Environment and Natural Resources (DENR) issued an Environmental Compliance Certificate (ECC) dated January 29, 2015.

b. The TARELCO I submitted the photocopy of the TCT No. 043-2014002758 with complete tax declaration and updated real property tax payment receipt together with the deed of absolute sale of the said land holdings.

c. Barangay Business Clearance and Social Acceptability from Barangay San Roque, this Municipality.

d. Zoning Certificate from the Municipal Planning and Development Office with Zoning Certificate number 2014-230;

Section 2. The proposed site for the 10 MVA substation and 69 KV Line of the TARELCO I situated within the hub of the Municipality is suitable for commercial purposes.

Section 3. TCT No. 043-2014002758 under the name of Tarlac I Electric Cooperative, Inc. intended for the construction, installation and commissioning of a 10 MVA substation and 69 KV Line, containing an area of six hundred forty five square meters (645 sq.m.), is hereby reclassified from residential to commercial area.

Section 4. The reclassification of the abovementioned lot shall take effect upon approval.

This ordinance shall take effect immediately upon approval.






