








RESOLUTION NO. 2016-045

RESOLUTION ENACTING MUNICIPAL ORDINANCE NO. 2016-165 - AN ORDINANCE NAMING OF "HILARIO VELASCO ROAD" IN HONOR AND MEMORY OF THE LATE HON. HILARIO BILLIONES VELASCO SITUATED AT BARANGAY CARMEN, ANAO, TARLAC.

WHEREAS, as mandated under section 13 of RA 7160, otherwise known as the Local Government Code of 1991, naming of Local Government Units, and Public Places, streets and structures, (c) the sanggunians of component cities and municipalities may, in consultation with the National Historical Commission of the Philippines, name or change the name of the municipal and barangay roads, avenues, boulevards, thoroughfares and bridges;

WHEREAS, Barangay Carmen recommended to name the road as "Hilario Velasco Road" per submitted Barangay Resolution No. 4, series of 2016 – resolution recommending the road situated at the southern part of Barangay Carmen, Anao, Tarlac, to be named as "Hilario Velasco Road".

WHEREAS, the road is an existing dirty road situated between the residential area and Alicante's farm at the southern part of Barangay Carmen;

WHEREAS, this Body deems it imperative to consider the naming and identifications of roads and streets within the territorial jurisdiction of the municipality;

NOW, THEREFORE, on motion of the Committee on Public Works and Land Utilization and Committee on Rules, and seconded by the Body:

RESOLVED that the Sangguniang Bayan of Anao, Tarlac, hereby promulgates and enacts:

AN ORDINANCE NAMING OF "HILARIO VELASCO ROAD" IN HONOR AND IN MEMORY OF THE LATE HON. HILARIO BILLIONES VELASCO, SITUATED AT BARANGAY CARMEN, THIS MUNICIPALITY.

Section 1. NAMING OF THE EXISTING DIRTY ROAD

The existing road having an area of one hundred fifty (150) meters in length and three and a half (3.5) meters in width, is hereby named as "HILARIO VELASCO ROAD".

In honor of the late Hon. Hilario Billiones Velasco who served as Barangay Captain of Barangay Carmen for almost twenty years from 1964 to 1984.

Section 2. Development

The said road is considered dirty road for it is not registered as barangay road. After the naming of the said road, allocation of fund for the improvement of the road can be allocated from the barangay fund.

Section 3. Repealing Clause

All previous ordinances or parts thereof in conflict with or inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 4. Effectivity

This ordinance shall take effect after ten (10) days from the date of copy thereof is posted in a bulletin board, at the entrance of the Municipal Building and at least two (2) conspicuous places, including Carmen Barangay Hall.
