**MUNICIPAL ORDINANCE NO. 2016-169**

**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2000-076, AN ORDINANCE INSTITUTIONALIZING THE GAWAD GALING PAGLILINGKOD SA MAMAMAYAN FOR THE OUTSTANDING PUBLIC EMPLOYEES OF ANAO, TARLAC.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF ANAO, THAT:

**Section 1. TITLE**

This ORDINANCE shall be known as **GAWAD GALING PAGLILINGKOD SA MAMAMAYAN**

**Section 2. COVERAGE:** The Gawad Galing Paglilingkod sa Mamamayan shall include the national and local employees of this Municipality, to wit:

- a. DECS (Elementary & High School)
- b. PNP
- c. Day Care
- d. Local Government Unit Employees

**Section 3. MANNER OF SELECTION**

3.1. The Search Committee for the Gawad Galing Paglilingkod sa Mamamayan has been created under Executive Order No. 2, s. 1999;

3.2. The criteria for the selection is based on the formulated rating sheets set by the Civil Service Commission and/or by the Search Committee;

3.3. The award is conferred by the Municipal Mayor during the celebration of the Philippine Civil Service Month on September of the current year and every year thereafter.

**Section 4. TYPES OF AWARDS**

4.1. The awards to be given to the deserving employees for their exemplary performance are as follows:

- a. Natatanging Punong Guro
  - \* Hanay A (Principal)
  - \* Hanay B (Head Teacher)
- b. Natatanging Guro (Elem. & H.S.)
- c. Natatanging Pulis
- d. Natatanging Day Care Worker
- e. Natatanging Kawani
  - \* Hanay A (Dept. Head)
  - \* Hanay B (Rank & File - Regular)
  - \* Hanay B (Rank & File - Casual)
  - \* Hanay C (Janitorial)

4.2. An awardee shall receive a plaque of recognition and a cash prize for his/her outstanding and exemplary performance.
